- No expiration date for this type of award.
- The option vests over a 1-year period, in equal monthly increments, contingent upon continued service to the Company.
- These RSUs vest 100% on the earlier of April 29, 2021 or the date of the first Annual Meeting of Stockholders following April 29, 2020.
